

Section 1 Note of Addendum to the FTB 204/ FTB 205 Manual

This manual is to be used with the FTB 304/FTB 305 Obstruction Lighting System.

The FTB 304/FTB 305 Obstruction Lighting System is similar to the FTB 204/ FTB 205. The differences in the FTB 304/FTB 305 are as follows:

- The FTB 304/FTB 305 operates *only* in *twilight* and *night* modes, but not in high-intensity day mode.
- The FTB 304/FTB 305 complies with the FAA Specification for L-865 lights.
- The FTB 304/FTB 305 operates with or without a controller.
- The FTB 304/FTB 305 operates with other FTB 304/FTB 305 Systems in a *master/slave* configuration (see the Installation Drawings supplied with the equipment).




Figure 1-2 FTB 305 Single-Phase Installation Wiring

- Disregard any wiring guidelines shown in the manual, and use the Installation Drawings in Figure 1-1 *FTB 304 Single-Phase Installation Wiring* on Page 1-4 and Figure 1-2 *FTB 305 Single-Phase Installation Wiring* on Page 1-5.
- Wherever FTB **204** appears in the manual, substitute FTB **304**. Wherever, FTB **205** appears in the manual, substitute FTB **305**.
- The photoelectric control is a PEC 507 or PEC 508.

Figure 1-1 FTB 304 Single-Phase Installation Wiring
